#### D. General:

The ARC recommended that all future Pilot Pool applicants meet license requirements as set forth under federal law, with requirements for service experience and tonnage as defined in CFR Title 46, Chapter I, Subchapter B, Part 11, Subpart G, or its successor regulations. In lieu of those qualifications, an Applicant with a master of towing license could provide acceptable alternative qualifications authorized by the USCG Chief of the Regional Exam Center through written directive. The ARC also recommended that this federal license requirement is set out the application for Deputy Branch Pilot appointment.
