A public meeting of the Board of Pilot Commissioners for Harris County Ports (the "Pilot Board") was convened on December 12, 2017 at 10:39 a.m., at the Port of Houston Authority Executive Offices, Fourth Floor Boardroom, at 111 East Loop North, Houston, Texas 77029. Chairman Longoria convened the meeting of the Pilot Board.

She added that although Captain Shearon would be missed, the Pilot Board welcomed Captain Mitchem and was looking forward to working with him and continuing the Pilot Board's important relationship with the Houston Pilots.
